

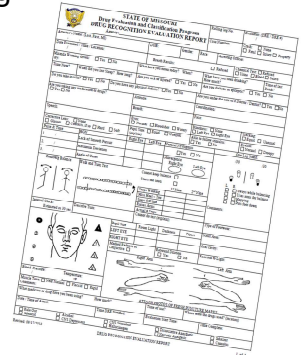

REJIS

This process, built to evaluate behaviors and attitudes in highway safety, focusing on drivers, passengers, pedestrians, and motorcyclists, is now electronic. The identification and measure of behaviors involved in crashes, and development of countermeasures to deter unsafe behaviors can now be easily measured with statistics, as evaluations are saved. Compliant with the NHTSA (National Highway Traffic Safety Administration) collection of data requirements, this system is designed for use by an investigator, regional coordinator, and state coordinator. Track evaluations, officer certification, reporting data, toxicology results, and agency identified skills in, one location.



The REJIS Commission is a government partner created to "serve the public interest through delivering quality, cost-effective technology services to the justice community and to government and quasi-government agencies." REJIS provides CJIS secure WAN/LAN connection services, data record management, data center collocation, and record management applications to law enforcement, prosecutors, and corrections agencies at the local, state and federal levels.

- Developed from current manual reporting standards initiated by the National Highway Traffic Safety Administration (NHTSA).
- For use by the DRE Officer, regional coordinator, and state coordinator to track evaluations and officer certification.
- Subject pedigree, interview, evaluation, drawings, opinion, toxicology, and approval pages flow in easy to follow succession.
- Agency desired DRE skills can be added and tracked.
- Drawings can be formed electronically or uploaded in PDF form.
- Officer can update personal account information and reset a forgotten password without external assistance.
- Integrated certification expiration notices.
- Clear indexed dashboard tracking unfinished evaluations, evaluations awaiting approval, and detailed evaluation inquiry.
- Printable forms for drawing convergence, arms, walk turn, and finger to nose tests.
- Once completed, evaluation data can be uploaded to NHTSA for statistical gathering.
- Help and user guide available on-line within the application.
