## Electronic Evidence Tracking

Tracking, filing, and keeping tabs on your agency's evidence quickly outgrows use of pen and paper. The REJIS Commission is a government agency created to "serve the public interest through delivering quality, cost-effective technology services to the justice community and to government and quasi-government agencies." REJIS' primary focus is to provide record management services to law enforcement, courts and corrections agencies at the local, state and federal levels. This includes interfaces to the Missouri State Highway Patrol MULES system; Missouri Department of Revenue (DOR); the National Crime Information Center (NCIC); the Kansas KCJIS and KDOR; and Nlets. REJIS was founded in 1976 under a cooperative agreement between St. Louis County and the City of St. Louis. Primarily concentrated in the metropolitan St. Louis and Kansas City areas, we service criminal justice agencies in Missouri, Kansas, and Illinois.

REJIS services include:

- Network, training and help desk support.

REJIS has approximately 140 employees located at three sites. Most of our staff and equipment are based at the REJIS building, in the Central West End of St. Louis.

## What is Evidence Tracking?

Electronic evidence tracking is a solution that puts you in complete control of all items of evidence from bagging, to tagging, to final release. Designed for the unobtrusive tracking of your agency's evidence, you can create unlimited designated locations, assign millions of item numbers, and control agency officer access. The system is your tool to maintaining a cohesive operation under your agency procedural requirements.

## Components of an Evidence Tracking System?

Useful evidence tracking systems consist of 3 core components:

- **Evidence Tracking Application** – The application is the backbone of any system and will determine what features and options are available. The main concerns when deciding are how detailed of reporting is available and whether it supports agency codes and identifiers that are unique to your procedural needs.
- **Growth** – Does the Evidence Tracking system have the capability to grow with your people, locations, item identification, internal audit security, and movement. Evidence requires record keeping that tracks trips to the lab and court, in addition to special circumstances for value and delicacy.
- **Barcode Readers and Printers** – All items need a unique identifier on them to be properly tracked. Barcodes clarity in printing, readability, and longevity are important factors for security and integrity.

## Choosing Your Agency's Evidence Tracking System

When putting together an effective and suitable evidence tracking system there are a few key questions to answer:

- How many location identifiers will you need? Envelopes? Drawers? Bins? Lockers? Garages?
- How many items do you need to track?
- What characteristics do you need to record and track for each item?
- Will you need to capture item images and documents?
- Do you need to produce tracking labels? Will you use barcode tags?
- What type of reporting will you need from the system?
- How many users will you have?
