LEWeb is a suite of PC based applications that provide user friendly access for entering and inquiring on information in regional, state and national law enforcement databases. Drop down lists using plain English in lieu of codes or abbreviations, auto population of data, and re-use of data along with fill in the box fields are hallmarks of LEWeb.

The REJIS Commission is a government partner created to "serve the public interest through delivering quality, cost-effective technology services to the justice community and to government and quasi-government agencies." REJIS provides CJIS secure WAN/LAN connection services, data record management, data center collocation, and record management applications to law enforcement, prosecutors, and corrections agencies at the local, state and federal levels.

## **REJIS** services include:

- Development of custom applications
- Installation and support of custom and commercially available software
- Custom interfaces
- IT Support Service
- Data center outsourcing
- Network, training and help desk support
- Information Security & Advisory Services

REJIS has approximately 140 employees located at three sites. Most of the staff and equipment are based at the REJIS building, in the Central West End of St. Louis.

## Benefits and Features

- Provides access to all regional, state and national law enforcement systems.
- Provides access to Missouri Department of Revenue and Nlets for out of state driver history (includes access to view photos) and vehicle/marine registrations.
- Provides capability to add photos to all regional law enforcement databases.
- Supports automatic entry/update in MULES of wanted/warrant, vehicle and missing person records from entry in the regional file for Missouri agencies.
- Provides interfaces to the Kansas KCJIS and KDOR systems for Kansas agencies.
- Provides access to St. Louis City, St. Louis County, and Jefferson County Corrections data in the Integrated Jail Management System (IJMS).
- Provides access to municipal court records from courts using the Integrated Municipal Docking System (IMDS) or the Integrated Municipal Docketing System Plus (IMDSPlus).
- Supports electronic warrant exchange from the municipal courts (IMDS and IMDSPlus) with the Regional Wanted Person system.
- Supports automatic entry of warrant records from the 22<sup>nd</sup> & 16<sup>th</sup> Circuit Courts.
- Supports electronic data transfers between various REJIS applications.
- Supports hyper-links from index records to full display and from linking points in one full record to another full display.
- Supports on-line look up of NCIC codes.
- Supports use of VIN assist to assure correct vehicle codes are used.
- Allows user to set certain preferences, such as font size, background color, system sounds, and frequently used access buttons.
- Retains responses for 30 minutes to facilitate repeat viewing without rerunning the inquiry.
